Warm up arena is indoors with felt/sand footing. Covered round pen available for lunging. No stalls or paddocks available for day-use. Do not leave horses unattended. Trails are available for use at riders discretion. Restroom facilities available in covered area. Keep vehicles to gravel driveways unless otherwise directed by show/facility staff. Practice good biosecurity with yours and other horses. Please clean up after yourself, taking all manure with you. Leave dogs at home or in your vehicle.
